### Product Description

Recombinant human angiotensin-converting enzyme 2 (ACE2) extracellular domain (19-740) was expressed CHO cells using a C-terminal Fc tag. The gene accession number is [AF291820](#).

### Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 90mM glycine.

### Storage and Stability

Store product at  $-70^{\circ}\text{C}$ . For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### Scientific Background

The angiotensin converting enzyme 2 (ACE2) belongs to the angiotensin-converting enzyme family of dipeptidyl carboxydipeptidases (1). ACE2 cleaves the angiotensin I and angiotensin II to counterbalancing ACE activity in the regulation of renin angiotensin system (RAS) (1). ACE2 also has the role in regulation of cardiovascular, renal and reproductive systems (1). In addition, ACE2 is a functional receptor for the spike glycoprotein (S) of SARS-CoV, HCoV-NL63 (2), and SARS-CoV-2, which causes the pandemic of the respiratory diseases (COVID-19) around the world in 2020 (3).

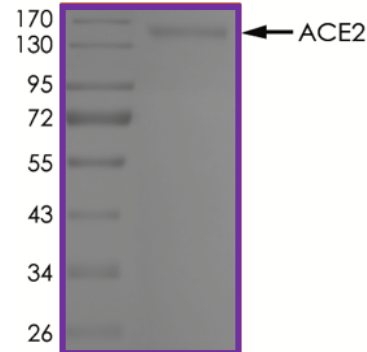

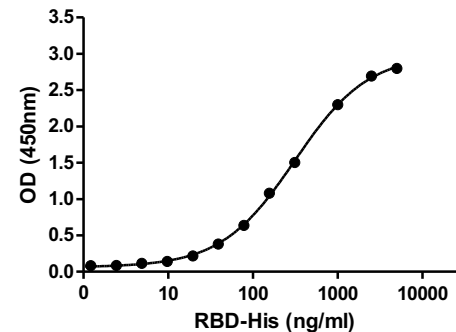
### Purity

The purity of ACE2 (19-740) was determined to be **>95%** by densitometry. Approx. MW **~150 kDa**.

### Activity



Measured by its binding ability in a functional ELISA. Immobilized human ACE2 (19-740) protein (Fc tag) at 2 $\mu\text{g}/\text{ml}$  (100 $\mu\text{l}/\text{well}$ ) can bind to 2019-nCoV spike protein RBD (His tag).
